MODEL DISPUTE MANAGEMENT PLAN FOR FEDERAL AGENCIES

I am writing to invite your views and comments on the possible form and substance of a Commonwealth model dispute management plan, and on the place for alternative dispute resolution in Commonwealth government agencies more generally.

The Attorney-General's reference to NADRAC

On 1 December 2009, the Attorney-General asked NADRAC to prepare a model dispute management plan for adaption and use by Commonwealth government agencies.

The reference is part of the Attorney's proposal to amend the Legal Services Directions to require agencies, unless an exemption is obtained, to develop and regularly review dispute management plans requiring appropriate use of alternative dispute resolution (ADR).

The proposal for a Model Dispute Management Plan stems from recommendations in the NADRAC Report, *'The Resolve to Resolve - Embracing ADR to Improve Access to Justice in the Federal Jurisdiction,'* which was provided to the Attorney-General in September 2009. NADRAC's advice to the Attorney is due by 30 September 2010. A copy of the reference is attached.

Your views and comments

It is envisaged that the Model Dispute Management Plan would be available as a resource to assist agencies develop their own specific plans for managing all internal and external disputes. A dispute management plan is not merely a litigation management plan. A dispute management plan deals with a wide range of conflicts with which agencies may become involved, not all of which may be appropriate for litigation for legal or practical reasons. A dispute management plan considers conflict from the point at which it first emerges.

In accordance with its Charter, NADRAC seeks the views and comments of a range of stakeholders. NADRAC is seeking input from a diverse range of external stakeholders beyond those who work in or directly with government agencies. Relevant stakeholders include federal
